



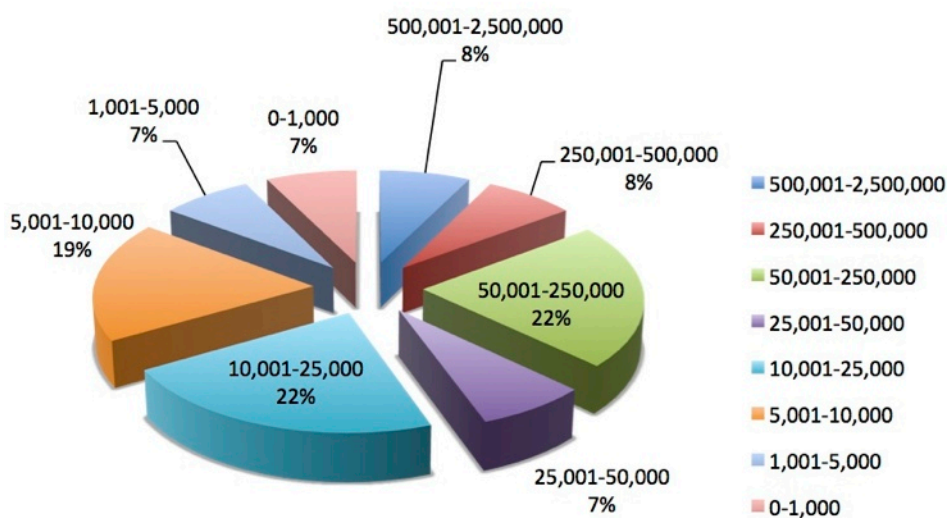

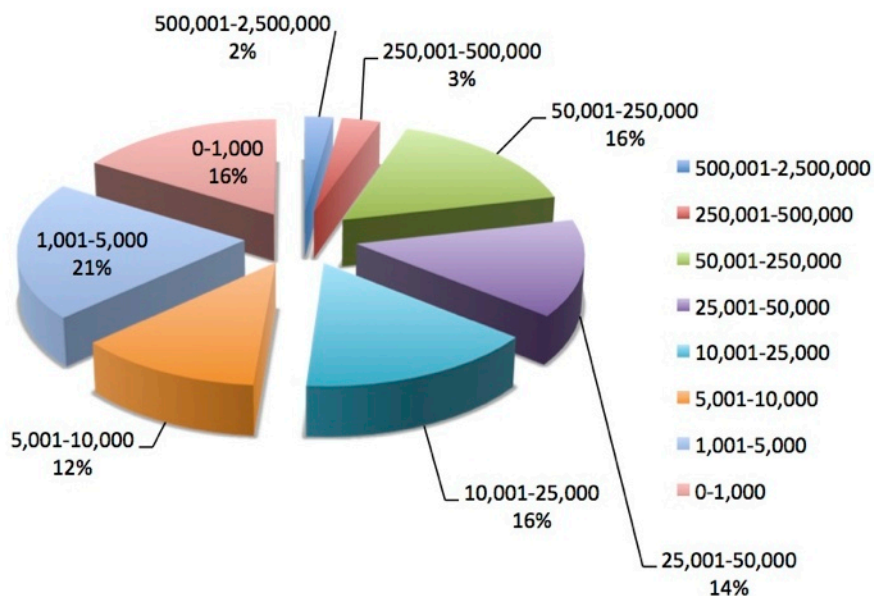

Dispute value (National avg.) in euro

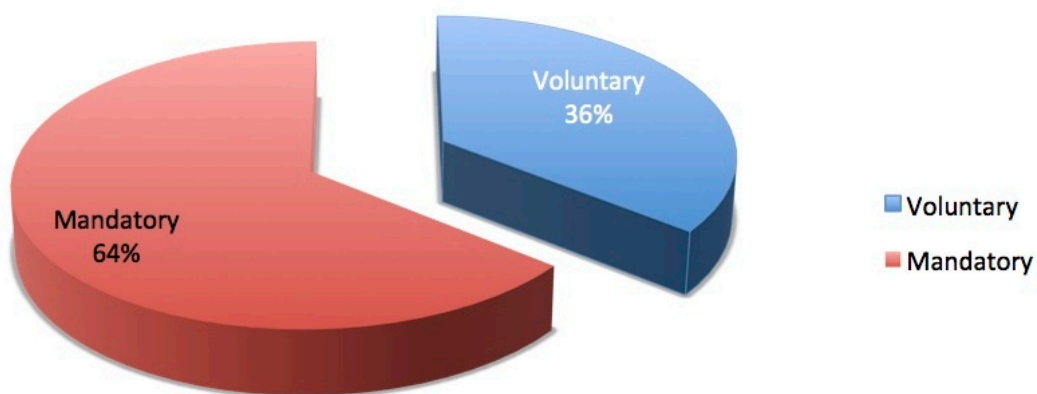




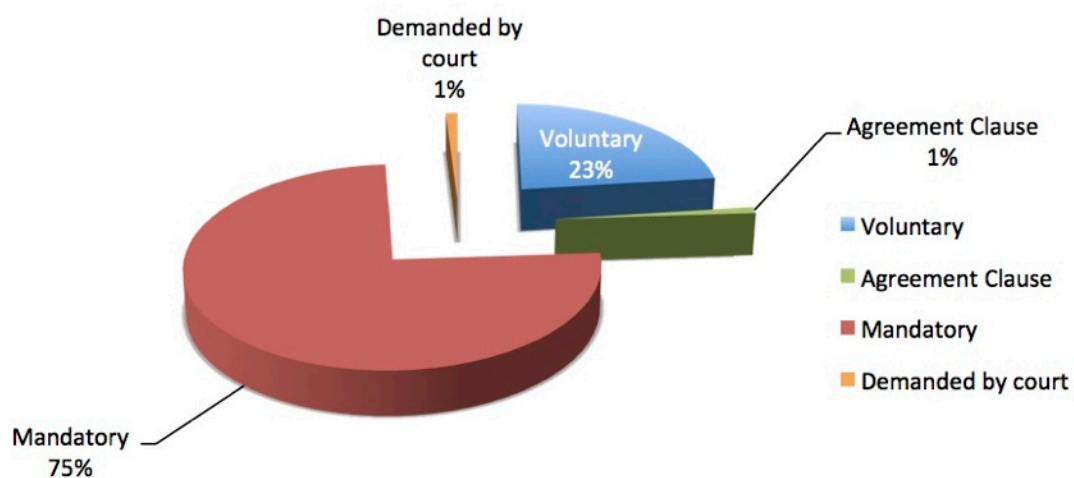

Mediation category (National avg.)

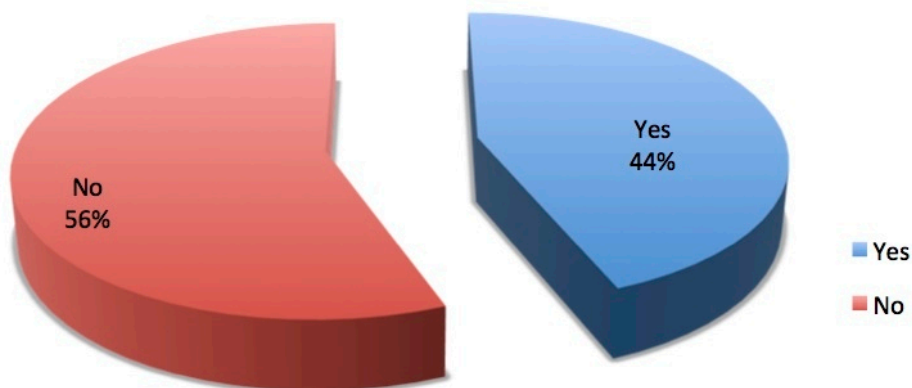




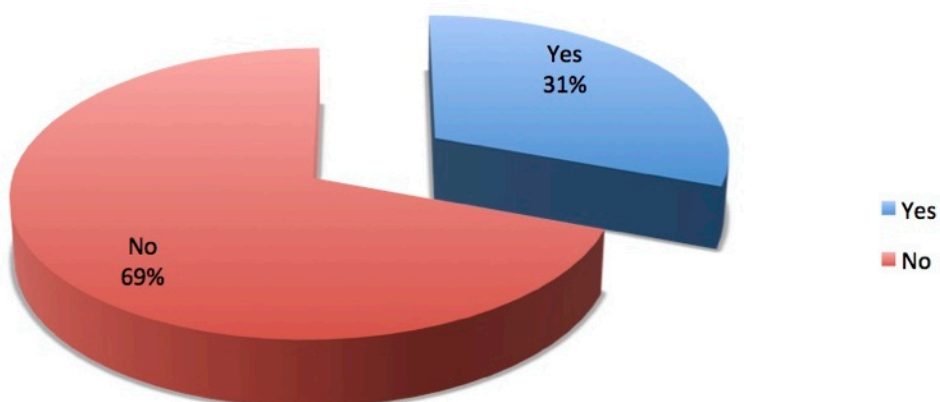

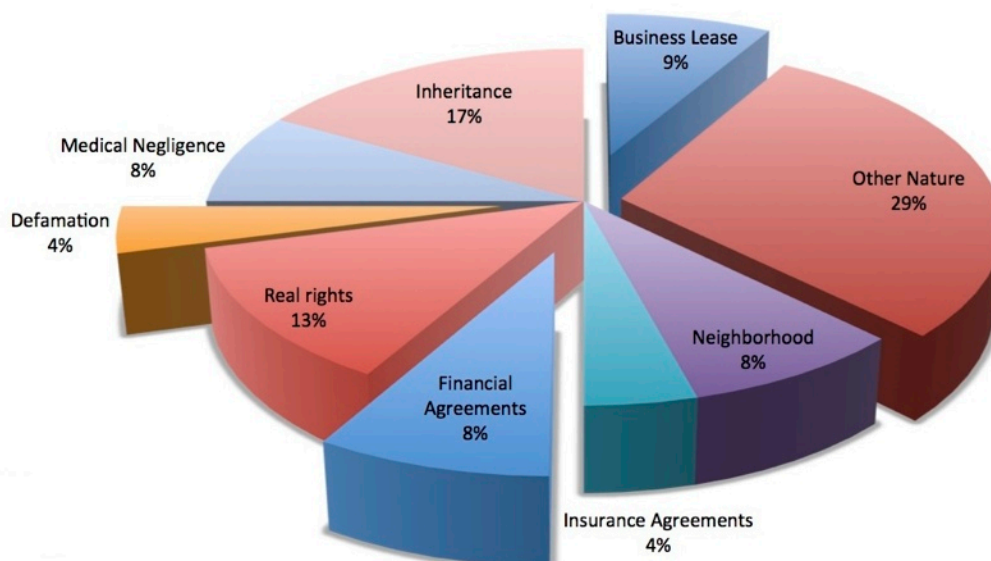
